Human Growth and Development Curriculum Outline

- I. The students will demonstrate their knowledge of the human male and female reproductive systems by:
 - A. Describing the structures and functions of both the male and female reproductive systems.
 - B. Discussing the importance of self and medical exams of reproductive organs.
 - C. Identifying common disorders of the reproductive systems.
 - D. Identifying steps to maintain reproductive health.
- II. The students will review and expand their knowledge and understanding of pregnancy and birth by:
 - A. Discussing fertilization, embryonic/fetal development, and birth process (3 trimesters)
 - B. Identifying the importance of prenatal and postnatal care.
 - C. Discussing teenage pregnancy.
 - D. Describing the three stages of birth.
 - E. Identifying complications that can arise during pregnancy and birth.
 - F. Modeling some of the responsibilities of parenthood
- III. Students will review and expand their knowledge and understanding of contraceptive methods by:
 - A. Recognizing the many benefits of abstinence from sexual activity until marriage.
 - B. Recognizing which contraceptives are commonly used.
 - C. Identifying the effectiveness of each contraceptive.
 - D. Identifying the benefits and disadvantages of each method.
 - E. Describing the side effects associated with each contraceptive.
- IV. The students will demonstrate and understanding of sexually transmitted diseases by:
 - A. Identifying and discussing sexually transmitted diseases.
 - B. Recognizing and distinguishing how different STDs can be acquired.
 - C. Identifying the symptoms of STDs.
 - D. Naming measures to avoid STDs.
 - E. Recognizing the need for medical treatment.
 - The students will demonstrate knowledge and understanding of the Human Immunodeficiency virus by;
 - A. Stating the meaning of the acronyms AIDS and HIV.
 - B. Discussing how the virus that causes AIDS is and is not transmitted.
 - C. Discussing the consequences of contracting HIV.
 - D. Naming good health behaviors that contribute to the prevention of HIV transmission.

The students will review and extend their knowledge of child abuse by:

- A. Reviewing definitions.
- B. Recognizing that abuse takes many forms, physical, sexual, and mental/emotional.
- C. Define sexual assault, rape, and date rape (both male and female).
- D. Distinguishing between sexual abuse, sexual assault, and sexual harassment.
- E. Discussing different approaches to use in avoiding sexual abuse and/or sexual harassment.
- F. Discussing and formulating different approaches to use in reporting abuse and/or sexual harassment.
- G. Criminal penalties for engaging in sexual activities involving a child.
- H. Sex offender registration requirements, including who is required to report, what information must be reported, who has access to the information reported, and the implication of being registered.
- VII. The students will discuss and expand their knowledge of bullying and other harassment issues by:
 - A. Identifying harassing, hazing, and bullying behaviors.
 - B. Analyzing stereotypes.
 - C. Dispelling myths related to sexual orientation and examining internet and other electronic dangers.
