## Wilmot Union High School Title I Parent and Family Engagement Policy



Wilmot Union High School will involve parents in regular, two-way meaningful communication addressing student achievement and ensuring:

- Build the schools' and parents' capacity for family engagement by providing parents with information on grade-level curriculum, achievement levels of state academic standards, assessments, requirements of Title I, monitoring their child's progress, and working with educators. Information will be provided during an annual meeting, through progress notices, at parent-teacher conferences, in the district newsletter, and on the district website.
- Provide materials, resources and training to help parents and families work with their children
  to improve academic achievement. Resources will be provided in district communications,
  through the school Learning Materials Center, and the school office. Parent trainings and
  family education nights will be planned each year based on the school needs assessment and
  may include a family Literacy Night and/or Math Night.
- Communicating regularly with parents in clear and understandable terms. This will include opportunities for parents to participate in decision-making roles, volunteer opportunities, Title I meetings, school newsletters, an annual parent survey, parent school compacts, and parent teacher conferences. Parent-teacher meetings will be scheduled at any time, as requested by parents.

- Coordinating parent and family engagement activities with other federal, state, and community programs, including after-school programs, etc.
- Providing educators, school leaders, and other school staff with opportunities to strengthen
  their knowledge and skills to reach out to, communicate with, and work with parents and
  families as partners in student achievement and school improvement.

This Wilmot Union High School Parent and Family Engagement Policy has been developed jointly with, and agreed on with, parents of children participating in Title I programs as evidenced by meeting minutes.
