

STUDENT NETWORK AND INTERNET ACCESS AGREEMENT

This agreement is entered into on (date) _____ between (student) _____ and the Wilmot Union High School District.

I understand and agree the purpose of this Agreement is to provide me with District computer access and use, District technology access and use, and network and internet access using the District's information technology network (hereinafter referred to collectively as the "Network") for legitimate educational and authorized purposes. As such, I understand this access may assist me in the collaboration and exchange of educational information, facilitate personal educational growth in the use of technology, and enhance educational information gathering and communication skills. **I understand and agree the use of the Network is for legitimate academic and educational support and enhancement of general information and research only.** I understand and agree the intent of this Agreement is to ensure that I will comply with all policies related to the use of the Network approved by the District, to help me understand and confirm my responsibilities and obligations, and to protect the interests of the District.

In exchange for the use of the Network, either at school or away from school, I understand and agree to the following:

- A. The use of the Network is a privilege and not a right. Use or access of the Network may be revoked, limited, or modified by the District at any time and for any reason. Inappropriate use, unauthorized use, or use not conforming to this Agreement or policy may result in revocation or suspension of this privilege, discipline of the user, and any other legal action available to the District.
- B. The District will periodically make determinations of whether specific uses of the Network are consistent with the acceptable-use practice. The District reserves the right to log and to monitor Network use, including electronic mail space utilization, by users. Such logging and monitoring will be conducted by the District without notice to users.
- C. There shall be no expectation of privacy for any user's Network use or access through the Network.
- D. The District reserves all rights to any material stored in files or transferred within the Network and will remove any material which the District believes may be unlawful, obscene, pornographic, abusive, or otherwise objectionable as permitted by law. Users will not use the Network or their District approved computer account/access to obtain, view, download, or otherwise gain access to such prohibited materials. The determination of what constitutes objectionable material shall be at the District's sole discretion. All information services and features contained on the Network are intended for the District's use of its registered users. Users are prohibited from allowing access to the Network by non-authorized users.
- E. All users shall expect to lose computer access for the following:
 1. Disrupting Network, equipment or system performance.
 2. Using another individual's access information.
 3. Entering internet sites unrelated to the education goals of the school.

- 4. Gaining or attempting to gain access to the Network and records.
 - 5. Attempting to illegally enter any computer system or file.
 - 6. Malicious use of the Network through hate mail, harassment, cyber bullying, profanity, vulgar statements, discriminatory remarks, or other inappropriate conduct.
 - 7. Unauthorized copying or use of licensed or copyrighted software.
- F. The District reserves the right to revoke or suspend any user's access to the Network for any reason deemed permissible by the District.
- G. The District does not warrant that the functions of the Network will meet any specific requirements the user may have, or that it will be error free or uninterrupted; nor shall the District be liable for direct, indirect, or consequential damages (including lost data, information, or time) sustained or incurred in connection with the use, operation, or inability to use the Network.

In consideration for the privileges of using the Network resources, and in consideration for having access to the information contained on the Network, I hereby release the District, which includes the District's Board of Education, its insurers, attorneys, representatives and agents, the Network providers, and the Network provider's operators and administration from any and all claims of any nature arising from my access, use or inability to access or use the Network.

I agree to abide by such rules and regulations of the Network as listed here and provided in the WUHS Student Handbook and within the WUHS School Board Policy and Administrative Guidelines.

As the student's parents/legal guardian, or as a responsible adult-student user, I willfully enter into this agreement and will indemnify the District and hold the District harmless, which for purposes of this Agreement includes the District's Board of Education, committees, commissions, officers, employees, insurers, attorneys, representatives and agents, from and against any and all liabilities, claims, losses, lawsuits, judgments, and/or expenses including attorney fees, arising, either directly or indirectly, from my use or misuse or my child's use or misuse of the Network.
